# **Software house expands marketadds VS**

The Software Systems Company in Sherman Oaks, California, has been a Wang software consulting company since 1975. Successful in several market areas (including property management, word processing, general accounting, trust accounting, insurance, and real estate), their corporate intent was to expand services to users of systems in the \$50,000 to \$150,000 range.

Shortly after Software Systems Company had researched the equipment of several manufacturers, the 2200VS was announced. Software Systems was one of a group of vendors invited to attend a special VS seminar at the Marriott Marina in Los Angeles. "I spent one day there, saw the machine, and just sat in awe," Craig Freeman of Software Systems Company relates. "I didn't think that Wang would get to the level of the VS - at least not that fast. The VS is more than an engineering achievement - it is a software achievement. So far as I know, it is foolproof. The utilities represent precisely how I would write an application program if I wanted a perfect application. It does not lock up at some point. It doesn't require you to flip through a manual or have a chart on the wall. You need the machine - and that's it! That's what amazed and intrigued me the most. After I had lost my third sale because I could not bid the hardware to take care of the job, it was obvious that this was the solution to arketing expansion needs — so we purchased one."



"The first 45 minutes I had the VS, I was apprehensive because I thought it was going to disrupt my whole organization with software conversion problems," relates Freeman. "Before the day was over, I had a grin on my face."

# GBS

In an effort to consolidate application software support, various people under the direction of Joe Glavin at the Wang Data Center have assumed the responsibility for several of Wang's software products. Included in the products that they will support is GBS. For now, the Data Center will be supporting the original T and VP versions (including the Distributor's version, Diskette version, etc.), and the GBS MVP version, as it is released.

they will also be handling all administrative and related functions regarding GBS. # General Accounting Applications on the VS

The VS General Accounting applications developed by Mini-Computer Business Applications, Inc., of Los Angeles, California are nearing completion. At this time, the following modules are complete and available for installation:

Order Entry/Inventory Control Accounts Receivable Accounts Payable

Payroll and General Ledger are expected to be complete and available for installation in mid-January.

We believe that these applications offer a tremendous opportunity to Wang vendors interested in supporting VS installations. They are highly transportable in that they are easy to understand and modify, as well as extremely well documented. Because MCBA views software vendors as their primary market, very structured programming techniques have been employed.

# New Products

# Hasp Multi-Leaving Concept

Telecommunications Product Marketing has recently released another IBM batch emulator which provides HASP multi-leaving emulation. This software package enables Wang 2200 series systems to emulate the telecommunications line protocol of an IBM 360/20 HASP multi-

leaving workstation.

The following discussion of HASP, multi-leaving workstations, and the multi-leaving concept provides an overview of the HASP environment.

#### HASP

HASP is an automatic spooling, priority scheduling system which operates in conjunction with IBM 360 or 370 operating systems. It supports an unlimited number of peripheral devices simultaneously, with normal job execution to perform the functions normally associated with off-line support computers. Included in HASP is a Remote Job Entry (RJE) feature which supports terminals and peripheral devices located remotely from the control computer via telephone lines (and moderns). As a result, a user located many miles from the central computer can submit jobs as if located locally. HASP will support a variety of batch terminals, some of which are 2780, 3780, 3741 and HASP multileaving workstation, both locally or remotely.

#### HASP Multi-leaving Workstation

As mentioned previously, the batch terminals, such as 2780 and 3780, can remotely submit jobs to, and receive jobs from, the central site under the control of HASP. However, because of the design of these terminals, only one job at a time can be submitted or received. Also, if a job is being transmitted to the central site, previous jobs submitted that are awaiting output back to the remote terminal must wait.

In order to overcome this throughput problem and support high volume remote RJE communications, a special program was developed for the IBM 360, Model 20, which allows it to function as a high volume batch terminal. Running in this mode, the 360/20 is a HASP multi-leaving workstation. In this application the 360/20 is usually equipped with a card reader, line printer, and console. A card punch is available but not widely used. When the 360/20 is operating as a HASP workstation, it has the capability of concurrent transmission and reception of jobs and console messages. It can support multiple job streams with concurrent send/receive transmission to the central site. The Wang HASP emulator program enables any 2200 series system to emulate the line protocol of a multi-leaving workstation, thus providing concurrent send/receive transmission of multiple job streams.

## Multi-leaving Concept

Multi-leaving is an advanced communications technique that provides for inter-leaving multiple data transmission jobs,

allowing more than one job to be communicated at the same time. Add to this the capability of concurrent send/receive transmission, and the result is an environment that allows the read and print peripherals to be active at the same time, thereby increasing system throughput. Thus, a user located at a remote site can be transmitting a file to the central site, receiving reports from either the central cite or a remote printer, and exchanging console messages, all inter-leaved so as to appear to be simultaneous. The Wang system can support up to five (5) concurrent job streams. It can transmit a job from either a card reader or disk, while receiving up to two jobs to disk and printer, plus support the sending and receiving of console messages. HASP supports character compression to reduce line traffic by eliminating the transmission of sequential characters. The output data block is monitored; whenever more than three of the same characters (including spaces) are to be sent, HASP automatically substitutes three character strings consisting of a control character, the number of characters to be sent, and identifies the character. These characters are regenerated at the receiving station.

# 3275 EMULATION SOFTWARE UTILITY (Non-Polled Dial-Up Mode Only)

Wang Laboratories, Inc., has announced an additional telecommunications software emulator for the 2200 series systems. This new offering now makes available a total of 8 different terminal emulators to meet the wide range of applications for those users requiring telecommunications.

With this software utility, Wang 2200 systems emulate the IBM 3275 interactive display terminal with communications to IBM host computers in non-polled dial-up mode. The 3275 terminal is a stand-alone display terminal which is connected in point-to-point mode to an IBM host computer for interactive communications from a remote site.

The 3275 emulator further broadens the telecommunications spectrum for Wang systems, enabling users interactive display capability with IBM host computers to create, access, and update data bases stored under IMS, CICS, or other programs using 3275 compatible access methods. The telecommunications applications performed by the 3275 are remote data entry, order entry, inquiry/response, and inquiry with data base update.

This offering is directed towards the Wang user whose primary needs are remote processing, but require supplementary interaction with a host computer. The intent is not to replace 3275 installations where there is a primary need for dedicated tasks such as full-time data entry activities, but to perform the various 3275 tasks for those users with limited 3275 requirements.

# Features

- IBM 3275 Bisync compatibility with speeds up to 4800 BPS.
- Supports any Wang printer.
- Data entry keyboard.
- Protected fields.
- Field checking.
- 24x80 display screen with 1,920 characters.

# Restrictions

- Connection must be via a dial-up line in a nonpolled environment. Only BSC point-to-point contention mode supported.
- A 2228C Communications controller is required.
- The PCS-II, WCS-15, and Disk Workstation will not support this emulator.

- The SDLC line protocol is not supported.
- Special IBM options such as light pen, repetitive keys, keyboard lock, and badge reader not supported.
- The 3275 small screen; 480-character display is not supported.
- No full-screen buffer for printing screen contents.
- Numeric lock for data entry keyboard not supported.
- Typamatic keys not supported (key holddown).
- ASCII transmission code not supported.
- Data entry into non-displayable fields not supported.

# Hardware

Requires a 2200-T with 16K memory, or a 2200VP or MVP with 17K memory. The 24x80 display is required along with a minimum 2270-1 diskette drive and the 2228C Telecommunications Controller.

# Logistics

Automatic enclosure with the 2228C controller. The BSC I software package may be ordered in lieu of the 3275 emulator at no charge, or it may be purchased separately. In stock, allow one week for delivery.

# Support

This is a Type 1, Wang-supported product. Any suspected bugs found in this package should be documented and sent to Wang Laboratories, Inc., via the local district analyst. Wang does not accept any responsibility for customer or vendor modifications to this package.

For proper installation of this emulator, ensure that the following conditions are met:

- Must have a 2200-T with 16K memory or a 2200VP or MVP with 17K memory. (This software is not supported on the PCS-II, WCS-15, or the Disk Workstation.)
- 3. Must have a 24x80 CRT display.
- Must have a point-to-point connection that is not polled (contention mode only).

# **ISS RELEASE 4.0**

Release 4.0 of the Integrated Support System (Package #195-0052-3) is now available for your use.

The part number for the ISS 4.0 manual is (#700-5010).

Below is a description of this current release.

# I. ENHANCEMENTS

- A. Software
  - 1. Utilities

The utilities have been enhanced with the following:

- a. General
  - Incorporated MVP code to increase efficiency.
  - Restructured logic for ease in maintenance and logical flow.
  - Consistent and comprehensive error checking, reporting and recovery.
- b. Copy/Verify
  - Capable of copying either program or data file exclusively.
- c. Create Reference File
  - File names in both the catalog index and reference file are displayed on the CRT for ease of operation when editing or creating a reference file.
  - The size of the reference file is only restricted by the amount of available memory.
  - Release 4.0 reference file contains an extra sector field that is

in compatible with past releases. However, the utility is modified so the user can convert past releases to present and vice versa.

- Reference file has the capability of being multiplexed.
- d. Format 2260C Disk
  - This standalone utility is now available with I.S.S. 4.0.
- e. Sort Catalog Index
  - There is no limit to the number of files in a catalog index. However, a sort is limited by the amount of memory available in the partition/system.
- f. Disk Dump
  - CRT output is available for vertical dumps.
  - If a file contains a password, the operator is required to enter the appropriate name.
- g. File Status Report
  - Ability to close every station for every muxed data file.
  - Lists every muxed data file for all stations.
  - Capable of listing every open muxed data file for each station.
  - For a specific station all muxed data files can be listed.
- h. Compression
  - "INDIRECT" processing mode is supported.
- i. Decompression
  - Processing in ''INDIRECT'' mode is now available.
- 2. KFAM7

The user file can now be multiplexed.

3. Screen/Disk Subroutines The new mux routines support both the VP and MVP. Mux Open ('217) will now issue a return code of "M" for all files which are not multiplexed when the value of the variable "S" equal -2.

- B. Documentation
  - ISS Utilities were rewritten into a narrative form due to the esorteric types receiving the package and concise wording of prompts and messages.
  - 2. Screen/Disk subroutines are contained within one chapter.
  - 3. A record and file format table were added to Sort 4 documentation.
  - KFAM5 documentation is merged with KFAM7 chapters.
  - In the following areas memory requirement tables were added for a quick reference and an operational guide:
    - a. Utility program memory requirements.
    - b. Memory requirements to sort a catalog index.
    - c. Memory requirements for creating a reference file.
  - 6. All rules for processing code under Decompression and Compression were included.

# II. LIMITATIONAL PROBLEMS

- A. Sort 4
  - 1. Sort 4 is limited to reading a field of 64 bytes or less. The following is a temporary solution:

Module 401A

Change Line 1120 from "HEX(CO)" to "HEX(FC)".

B. KFAM7

Processing in REORG function leaves an entry in the global table. A temporary solution is to perform an open and close after the REORG.

C. Decompression

Extra sectors may not be what the user specified in creating a file.

1. The program allocates an area 3 times the

input file size.

 After decompression extra sectors may only include sectors that are available within the allocated area.

# **MVP BASIC-2 RELEASE 1.4**

Release 1.4 of MPV BASIC-2 corrects a disk drive conflict concerning 2260B-2 and 2260C-2 disk drives. If one MVP partition is accessing one of the drives of the pair and another partition attempts to access the other drive, the MVP OS causes the disk processor to forget which drive it is currently accessing. This can result in an abnormal termination of the disk operation (often error I93 is reported). The following file on the system platter differs from Release 1.3:

"@@" - MVP OS AND BASIC-2 Interpreter

A general release to the existing customer base is not being made at this time, since Release 1.5 is expected to be released in the near future. However, any existing customers with 2260B-2 or 2260C-2 drives should be upgraded to Release 1.4.

MVP RELEASE 1.4 system platter is part number 701-2294D. If you require a copy of this release, please contact your local District of Branch Analyst.

# MVP-A

The new "A" version of the 2200 VP and MVP Central Processor Units is now available. This announcement coincides with our recent announcements of expanded memory on the MVP and the new 2260C/BC and 2280 series disk systems. The new disk products utilize new disk controllers, which operate the 2200 VP/MVP power supply almost to capacity. Under certain configurations, the power supply could possibly go into a marginal situation (particularly in areas with low line voltage problems). In light of this possibility and the potential for future product announcements, we have developed the "A" version of the VP and MVP Chassis. This option is mandatory on all VP or MVP systems orders containing a Model 2280 disk system or an MVP with more than 64K bytes of memory. It is recommended that the "A" option be quoted in all new sales situations where system growth is a factor.

The option "A" must be included in situations where customers wish to add a Model 2280 to an existing VP or MVP installation. For customers wishing MVP memory

upgrades it will not be necessary to order the "A" option provided there is not a model 2280 in the system.

Upgrades will be available for existing systems with deliveries for the "A" option scheduled to coincide with deliveries for the Model 2280 (late January 1979).

The new "A" option was included in the Oct. 15 price list. To order the "A" option you need only add the "A" suffix to the current VP/MVP model number; Example 2200 MVP-16A.

# 2280 FIXED/REMOVABLE DISK DRIVE

Wang Laboratories, Inc., has announced a new fixed/removable cartridge disk drive: the 2280.

# **General Discussion**

The 2280 is available in three models: Model 2280-1 provides approximately 13.4\* million bytes of removable storage and 13.4 million bytes of fixed storage for a total capacity of 27 million bytes. The 2280-2 provides approximately 13.4 million bytes of removable storage and 40.2 million bytes of fixed storage for a total capacity of 53.6 million bytes. The largest drive, the 2280-3 provides approximately 13.4 million bytes of removable storage and 67.1 million bytes of fixed storage, for a total capacity of 80.5 million bytes of on-line storage.

# Features

- Removable disk platters make off-line storage capability virtually unlimited.
- Disk platters are easy to unload, store, and replace.
- Disk utilization optimized for efficient cost/performance ratio.
- Removable platter offers backup for user's critical files and data records. Files may be backed up by removable platters, removing the necessity to purchase another drive or tape transport for duplication purposes.
- Fast/efficient accessing and disk copying speeds.
- Improved storage/physical space ratio provided, as compared to 2260 series.
- The 2280 disk drive controller, the 22C14 allows two disk drives to be daisy chained, providing up to 16M bytes of on-line storage.

• Field upgrades will be permitted between models.

\* Please note that storage capacity figures do not allow for small loss due to automatic error correction logic.

# Restrictions

- The 2280 fixed/removable drive will *not* work with the Wang 2200T, PCSII, WCS-15, and VS Series.
- Model 2280 removable disk platter is *not* compatible with the 2260 series.
- Model 2280 controller does not support the MXA-1 at this time.

# Order Information/Availability

First deliveries of the 2280 fixed/removable cartridge disk drive will be in January of 1979.

# **VS PRODUCT ENHANCEMENTS**

Wang has announced further additions to its VS product line. These enhancements will further increase the power and flexibility of a system which is already more powerful and flexible than any product currently being sold in its price range. These announcements are of particular significance because of their implications for distributed processing and the increased upgrade-potential that they afford our customers and prospects.

# Features

2280V Fixed/Removable Disk Drive provides fast, highvolume, direct-access storage for Wang VS systems. The 2280V is a free-standing unit ideally suited for integration into the office environment. The disk drive is enclosed in a functional cabinet that requires a hinged front door for the loading and removal of the disk cartridge. The 2280V comes in three models:

- 2280V-1 holds two disk platters, one 15-meg. removable and one 15-meg. fixed, for a total of 30 meg. of storage.
- 2280V-2 has one removable 15-meg. disk platter and two fixed platters. One fixed platter has a single recording surface with a 15-meg. capacity; the other has two recording surfaces with a 30meg. capacity, for a total of 45-meg. of fixed storage. Total storage is 60-meg.
- 2280V-3 has one removable 15-meg. disk platter

and three fixed platters. One fixed platter has a single recording surface; the other two have two recording surfaces, for a total of 75-meg. of fixed storage. Total on-line storage capacity is 90-meg.

# Benefits

The 2280V allows for greater flexibility in configuring, and increases the cost effectiveness of the VS System. Because of the fixed/removable features of the 2280V, the customer is now able to back up files without investing in backup peripherals. The fact that the 2280V is fieldupgradable is also a definite plus when it comes time for the user to expand his system.

### Limitations

The 2280V is a fixed/removable drive. The fixed represents one volume, the removable another volume. The VS will not support multivolume processing.

# Features

2209V-2 dual-density 9-track tape drive supports 800 and 1600 BPI densities. The characteristics of the 2209V-2 are the same as the 2209V except that the 800 BPI speed is 60K bytes-per-second, and it utilizes NRZI encoding.

# **Benefits**

The 2209V-2 represents another addition to the growing line of powerful VS peripherals, that will enable us to offer positive solutions to our customers' data processing needs.

# Limitations

The 2209V-2 is interfaced to the new 22V05-2 IOP and subject to the same limitations as the 2209V nine-track tape drive. The 22V05-2 replaces the 22V05 as the standard tape drive IOP.

# Features

22V08 is an input/output processor for disk drives. The 22V08 will support all models of the 2280V, the 2265V-1, and 2265V-2. The 22V08 replaces the 22V03 and 22V04 disk input/output device. The 22V08 will support four disk drives in any combination.

# Benefits

The 22V08 IOP allows three different disk drives to be

supported by a single IOP. This is a significant cost-saving and upgrade factor to the user.

### Limitations

The maximum number of 22V08's supported by all CPU models is two.

### Features

- 22V06-1 A one-line communication input/output processor supporting a single synchronous line. Supports a 2780/3780 emulator, (included), and provides an automatic calling unit. Can be field-upgraded to a 22V06-2 and/or 22V06-3.
- 22V06-2 A two-line communication input/output processor supporting two synchronous units. Supports a 2780/3780 emulator, (included). An automatic calling unit is provided for one of the two available lines. Can be fieldupgraded to a 22V06-3.
- 22V06-3 A three-line communication input/output processor supporting three synchronous lines. Supports a 2780/3780 emulator, (included). An automatic calling unit is provided for one of the three available lines.

# Benefits

The 22V06 Communications IOP gives the VS the highpowered communications capability that is demanded in the rapidly-expanding, distributive-processing marketplace. The fact that the 22V06 is field-upgradable is also a definite plus when it becomes necessary for the user to expand his operations.

### Limitations

Required modems are not included. With the initial release, only half duplex will be supported. The 22V06-1 became available for limited customer installation in November; the 22V06-2 and 3 in December.

### Features

2249V

- Cluster Controller is physically a stand-

alone device. The Cluster Controller is equipped with a cable to be connected to a modem, and a number of coax connectors which are to be connected to serial workstations and serial printers. The 2249V comes in one model, the 2249V-6, and is capable of supporting up to six devices. These devices may be either the 2246S workstations or any of the serial printers.

# **Benefits**

The 2249V will allow the VS to perform remote interactive processing. It will also allow multiple users at the remote location. The serial devices can be located as much as 2,000 feet from the cluster controller. The 2249V will allow the user to have the same benefits at the remote location as those enjoyed at the primary CPU location.

# timitations

It is important to note that the cluster is linked over telephone lines to another modem which, in turn, is connected to a 22V06 IOP resident in the VS. One of the serial devices must be a 2246S Workstation. The 2249V-6 will be available in May of 1979.

# Features

22V07-1 - An input/output processor providing up to eight serial ports supporting the 2246S workstation or serial printers.
 22V07-2 - An input/output processor providing up to 16 serial ports supporting the 2246S workstation and serial printer.

# Benefits

The 22V07 Serial Input/Output Processor now allows serial devices to be located in excess of our previous 500-foot limitation. In conjunction with the increased distance, this enhancement also allows us to increase the maximum number of workstations we can support from 24 to 32.

# mitations

The maximum a serial device can be located from the input/output processor is 2,000 feet.

# Features

- 2246S A serial workstation connected to the 22V07 via coaxial cable. Maximum distance is 2,000 feet. The workstation has an 80x24, 12-inch CRT with the same features as the 2246P. The 2246S can also be connected to the 2249V Cluster Controller at a distance of up to 2,000 feet.
- 2246R 2246R is a 12" U/L CRT (80x24) remote workstation. Includes communications controller which allows it to operate as a remote standalone workstation. The 2246R also has a built-in parallel interface which enables it to support a single parallel printer.

# Benefits

The 2246S and the 2246R are new workstations. The 2246S now allows operation at increased distances from the CPU or the 2249V-6 cluster controller, a fact that will allow us to address many application requirements that in the past we could not fulfill. The 2246R enables single remote workstations to be placed at locations that don't have a multi-user requirement but do have a need for remote processing.

# Limitations

The 2246S will be deliverable 12 weeks after receipt of order. The 2246R will be available May of 1979.

# Features

Serial printers are the same models as the current parallel models that are now available on the VS. All performance characteristics remain the same; however, there are modifications to the equipment. The new serial printer model numbers are: 2221V-S, 2231V-2S, 2231V-6S, 2261V-S, 2263V-1S, 2263V-1S, 2263V-2S, 2263V-3S, 2281V-S,

# Benefits

The introduction of a full line of serial printers allows the user a broad range of peripherals from which to choose. Whether his needs are for increased distance at his primary location or a high-volume operation at a remote site, the serial printers will fill the bill.



### Limitations

Serial printers will only be supported by the 22V07 Input/Output Processor and the 2249V-6 Cluster Controller.

# 2260BC DISK DRIVE

### Introduction

Wang Laboratories, Inc., has announced a new fixed/removable cartridge disk drive, the 2260BC. This new drive is functionally identical to the 2260C with one major exception: the 2260BC provides for disk multiplexing.

### Differences Between 2260C and 2260BC

The physical difference between the 2260C and the 2260BC is in their respective controllers. The 2260BC uses a new controller, the 22C13, which has an additional connector into which the cable from a 2230-MXA-1 is attached. Unlike the 2260B drive, where the 2230-MXA replaces the 22C02 disk controller in multiplexed configurations, the 2230-MXA-1 provides the multiplexing function only and occupies a separate I/O slot on the central processor unit. Therefore a total of two I/O slots are required on the CPU.

#### Features

- The 2260BC includes a cabinet/stand which supports the drive. This stand contains an internal area in which a 2200T, VP or MVP central processing unit may be installed.
- Cuts down need for subsequent furniture purchases.
- Standardizes the Wang family of hard-disk based systems. The new 2260BC drive will be phased into delivery while the 2260B drive begins its phaseout.
- Offers inexpensive hard-disk-based system with upgrade capabilities within Wang product line.
- Offers upgrade capabilities with other systems via multiplexing configurations.

### **MVP MEMORY UPGRADE**

### Introduction

Wang Laboratories, Inc., recently announced memory expansion allowing up to 245K bytes on the 2200MVP series small business computer.

# **General Discussion**

The 2200MVP series processor now may be ordered (or upgraded) to the following memory sizes: 16K, 32K, 48K, 64K, 96K (88K partitionable), 128K (120K partitionable), 192K (176K partitionable), 256K (232K partitionable).\* No memory figures specify the 3K lost to operating system overhead.

Total memory of the 2200MVP is divided into a maximum of four (4) independent banks. Each of these banks can contain up to 64K bytes. The first bank holds the MVP operating system which controls the functions of the computer, requiring 3K bytes of memory and can reference partitions in any bank. A 5K block of memory is available in this first bank for universal global partition(s), accessible to all other memory banks in the system. Ideally this area would be used for variables and subroutines required by partitions stored in any of the banks (for example, KFAM-7 tables containing file and record protection information). The balance of the memory available in the first bank (56K) is partitioned normally.

The second, third, and fourth memory banks can each have up to 64K bytes of memory. They are configured at partition generation time into customer-defined partitions which may be global within that bank. The customer has up to 56K available from the maximum 64K bytes for user codf the initial 8K bytes of each bank (after the first) being required by the system. In addition to the 56K available to the user in these banks, the universal 5K global partition area in bank I is

also accessible. Memory allocation is shown in the following diagram:



\*Please note: 1K per partition is also claimed by the system.

# IBM 3270 Information Display Systems

Wang Laboratories, Inc., recently released a new telecommunications terminal emulator. This emulator allows the Wang 2200 Series to emulate the 3275 display terminal. The following article is included to give those people not familiar with the IBM 3270 family an overview and an understanding of the product, and the marketplace in which it is sold.

## Introduction

Telecommunications (TC) is becoming a more important facet of the total business picture at Wang. As we come into greater contact with people in the TC field, we must be able to communicate to them what our products can and cannot do. Generally, we describe our devices' TC capability by comparing them to other devices which are "industry standards." For instance, we can provide 2780 support. This indicates that our device communicates to another device using the telecommunications message structures, length, codes, and protocol of an IBM 2780 Data Communications Terminal. Wang presently provides several communications emulation devices and will introduce others in the near (and not so near) future. One of the most common devices in telecommunications is the IBM 3270 Information Display System. Wang presently provides communications emulation for the IBM dial-up 3275 system. A basic understanding of the 3270 is desirable for anyone likely to become involved in telecommunications.

## IBM 3270 Style Interactive Telecommunications

The 3270 is an interactive display device (or series of devices). These devices operate under the control of a central processor regardless of the physical network, and do not support a data base at the device. The 3270 operates in two general modes: data entry and inquiry/response.

During a data entry operation, the 3270 device operator keys information into the display. When a screen of data is finished, the operator touches an "enter" key. Meanwhile, the Central Processing Unit (CPU), or a device attached to the CPU, has been polling its attached devices, including the 3270, with a TC program. When the next poll message addresses the 3270 with "enter" flagged, that device will send the data from the screen to the CPU. This may be a full screen of data, or only a few lines. After the CPU acknowledges receipt of the data, the screen is reset to a normal state (which usually is a blank format), and the operation is repeated. Because the CPU knows which device sent the data, it can input this data to the correct applications program for storage at the CPU.

The inquiry/response operation is similar. The operator enters a certain amount of information (generally a customer number, etc.) and then touches either "enter" or another preselected key. The CPU has been polling, and will allow the 3270 to send its message (for instance, the customer number). The CPU supplies this information to an applications program. The applications program accesses its data base and presents the resultant data (in this case, customer name and address) to the CPU. The CPU then sends that data to the 3270, where it is displayed; the operator is then able to enter more data.

There are a number of other interactive devices in use. Generally, however, they all operate much like the 3270. Essentially, all operations are Data Entry, Inquiry/Response, or some variation of the two.

3270's are hardwired devices which operate in a specific manner. Because their operations cannot be altered to meet different conditions, they are often referred to as "dumb" devices. Many of the 3270 replacement devices are "intelligent" (they contain memory and are programmable) but are programmed to emulate the "dumb" 3270.

Host systems that can operate with the 3270 include most models of 360/370 and System 3 Model 10 and 15.

IBM introduced the 3270 early in the 1970's. Synchronous Data Link Controllers, printers, and display devices were added in 1977. The entire 3270 family consists of a number of component devices with similar numbers.

### Specific 3270 Device Descriptions

A 3270 Device Summary Table, located at the end of this article, lists these devices and their different models. Figures A-E illustrate the basic configurations of these devices.

The first devices to be introduced were the 3271, 3272, 3275, 3277, 3284, 3286, and 3288.

The 3275 is a remote, stand-alone, display station which can support a non-buffered 40-cps printer. This display station has internal control circuitry and can operate using either Binary Synchronous Communications (BSC) or SDLC. Under BSC, this device provides dial-up operation making it the only 3270 device to operate with other than dedicated lines. The 3275 can also operate on multipoint, non-switched lines and is often found in this environment. Two screen sizes are available, 480 and 1,920 characters. See Figure A.

The 3271 is the remote cluster controller. It can interface up to 32 terminal devices, either displays or printers, to a BSC or SDLC line. One device must be a display. The 3271 can operate on a multipoint line. Because any Transmission Control Unit (TCU) line at the host site can support multiple 3271's, and each 3271 can support multiple terminals, line loading analysis is extremely important. The 7200-bps (maximum) line speed supported by the 3271 restricts the number of terminals per line. Commonly, a 2400-bps line will support to more than 12 terminals, even though there may be multiple 3271's attached to the line. See Figure B.

The 3272 local controller functions in much the same manner as the 3271, except that the 3272 connects terminals directly to the CPU channel. This device supports up to 32 terminals across a coax cable. The IBM channel interface is very complex, and the bulk of the 3270's are supported remotely using TCU's like IBM's 270X or 370X. Therefore, it is unlikely that Wang will provide 3272 support. See Figure C.

Both the 3271 and 3272 support the same display terminal: the 3277. The 3277 may have two different screen sizes, either 480 or 1,920 characters. There are many different keyboards which can be attached to the 3277 by cable. These are variations of typewriter, keypunch, or data entry keyboards with many foreign keysets available. The 3277 can optionally be obtained with keylock, photopen, or badge reader. The photopen is useful for item selection from lists. The keylock and badge reader provide system security. (The 3275 display is the same as the 3277.)

The 3284, 3286, and 3288 printers were introduced with the 3271 and 3272. The 3284 is a 40-cps matrix printer and can be used with 3271, 3272, or 3275. The 3286 is a 66-cps matrix printer, and the 3288 is a 120-lpm belt printer. The 327 cannot support the 3286 or 3288.

In May of 1977, IBM announced a major revision in the 3270 product line. This version consisted of price reductions

to the foregoing devices and the introduction of a new series of controllers, displays, and printers. The 3274,3276, 3278, 3287, and 3289 were added to the product line. These devices, in general, offer better price and performance than the older devices, even after the price cuts. They also provide features which eliminate some of the undesirable characteristics of the earlier models. The features include up to 9600-bps communications, low glare screens, local print (no mainframe intervention), and many others.

The 3274 is the cluster controller. It can interface up to 32 new Terminal devices either via BSC or SDLC, or locally to multiplexer or selector channels (either Systems Network Architecture (SNA) or non-SNA compatible). Or the 3274 can support up to 16 of the older (3277, 3284, etc.) terminals. Old and new terminals can be mixed within some restrictions. See Figure D.

The 3276 provides remote small cluster support. The

3276 can function as a stand-alone controller/display and can also support an additional seven terminal devices. The 3276 display is available with 960, 1,920, 2,560, or 3,440 characters. See Figure E.

The new 3278 display is available in the same screen sizes as th 3276. Up to seven 3278's can be attached to a 3276 and up to 32 to a 3274. This device displays a 94 upper- and lower-case characters set. There are many keyboard variations available, as well as keylock, photopen, and badge reader.

Two new printers are available. The 3287 is a bidirectional matrix printer which is supported by 3274 or 3276. There are two models available with 80- or 120-cps (maximum) speeds. A new, higher-speed belt printer, the 3289 can print from 80- to 400-lpm, depending upon character set and line length. The printer is supported by the 3274 either remotely or locally, but not by the 3276.

# Technical Notes

The 2200 systems upgraded to 2200 MVP's are required to replace existing consoles with 2236D terminals. The 2236D is the only terminal supported by the MVP. It may be advantageous for some systems to make limited use of the old console in the MVP, rather than trading-in or scrapping the console.

# CRT (2216, 2226, 2220, 2210, 2292)

The CRT can be used on the MVP in the same manner as any other printer-type device. It's particularly useful for monitoring background jobs. A portion of the screen can be reserved for each job's status messages; \$OPEN, \$CLOSE and PRINT AT can be used to control where information is displayed and to prevent jobs from interspersing their messages on the screen. The CRT controller address cannot be set to /005 since this is a reserved MXC address; the printer addresses /015, /016, or /017 are logical settings for the monitor.

# Keyboard (2215, 2222, 2223, 2226, 2220, 2210)

The use of keyboards, other than in the 2236D, is quite limited on the MVP and is, in general, not recommended. The following restrictions apply to the use of auxiliary keyboards:

- The keyboard controller address cannot be /001 since that conflicts with the MXD; /008 can be used. The triple controller does not have address switches for the keyboard and, thus, cannot be used.
- The keyboard operations CI, INPUT, and LINPUT are legal only to the MXD/22236D. Only KEYIN and \$GIO can be used with the auxiliary keyboard.
- The RESET and HALT keys must be physically disabled since depressing them will RESET or HALT whichever partition happens to be executing at that moment. RESET may also lock the system up, requiring re-initialization in order to restore operation.
- 4. Typing rates are severely limited since the keyboard contains only a single character buffer. The MVP does not poll the keyboard frequently enough to support typing; thus, data may be lost, even at moderate typing speed. It is possible, however, to use the keyboard to initiate or control tasks if a single character input is sufficient. For

example, a menu might be displayed which the operator responds to by pressing a Special Function Key.

# Storage Devices (2210, 2220)

Cassette drives and mini-floppies are not supported on the  $\ensuremath{\mathsf{MVP}}\xspace.$ 

# 2236D Terminals on a 2200T or 2200VP

In order to facilitate a possible upgrade to an 2200MVP, a 2200T or 2200VP can be configured with an MXD and one (and only one) 2236D. The terminal behaves like a 2226 in all respects except:

- The communication rate is considerably slower than that of the 2226. However, at 19.2K baud with the automatic compression capability of the MXD/2236D, the transfer rate is generally quite adequate.
- 2. The keyboard arrangement is different.

The 2236D provides additional capability:

- 1. Remote terminal hookup.
- 2. Terminal printer jack.

# Hello.Tech Center.

We would like to clear any confusion that may exist on the different 2200 series *disk drives*, and provide you with the do's and don'ts of configuring them with the 2200:

1. The disk platters of the old 2230 drives are not

*interchangeable* with the newer 2260BC and 2260C drives. In other words, the 2260BC and the 2260C series disk drives cannot read, write, or format the 2230 series disk drives, and vice versa.

- 2. The 2260BC drives must always be configured with the 22C13 controller plugged into the main CPU. The 2260BC can also be multiplexed; if it is, then the disk multiplexer controller 2230MXA-1 must be used *along with* the 22C13 controller. Therefore, multiplexing the 2260BC will involve *two* I/O slots.
- 3. The 2260C drive *cannot* be multiplexed. The 22C12 disk controller must always be used when configuring the 2260C.
- 4. The 2260B, 2260BC, and the 2260C disk *platters* are all interchangeable. Therefore, the BC and C platters can be formatted, read from, or written onto when mounted in any 2260 series drive.
- 5. 2260C and BC drives cannot be connected to 2260B controllers.

# PCS-II/PCS-IIA

The PCS-II has no disk controller and, therefore, *cannot* be configured to any of the hard disk drives. The PCS-II has its own mini-floppy drives mounted on top of the console; and, presently, that is its maximum configuration.

The PCS-IIA, on the other hand, has disk multiplexer closely resembling the 2230MXB and can therefore be configured with 2200T, VP and MVP systems containing 2260B, BC or C drives.

# VP/VP-A and MVP/MVP-A

The new model disk products utilize new 2260BC, C and 2280 integrated disk controllers which operate the 2200VP/MVP power supply almost to capacity. Under certain configurations, the power supply could possibly go into a marginal situation (particularly in areas with low line voltage problems). In light of the possibility and potential future product announcements, we have developed an "A" version of the VP and MVP chassis.

The "A" option is mandatory on all new VP or MVP

system orders if the order contains (a) a 2280 disk system, (b) an MVP system with memory greater than 64K bytes, or (c) both. In addition, the "A" option is required when a model 2280 is added on an already installed system. The purpose of the "A" option is to provide adequate expansion room in situations where system growth is a factor.

# Questions, Corrections and **Amplifications**

GUS is now (not "not") available on minidiskette 195-2061-8 as previously stated in Newsletter #10.

### Disk Model 2280 Capacity

The recent announcement of the 2280 disk drives raised some questions as to their precise capacity.

Each platter on a 2280 drive has 819 tracks. There are 64 sectors on a track or 52,416 sectors; this yields a total of 13,418,496 bytes per platter.

The storage capacity for the three models are:

2280-2	53,673,984
2280-3	80,510,976

In all cases, 13,418,496 is removable; the remainder is on from 1 to 5 fixed surfaces, depending on the model.

In addition, there are 256 sectors (4 tracks) reserved on the fixed platters for error correction. The total usable space on a fixed platter is 13,484,032 bytes; however, at no time will the user be able to access more than 13,418,496 bytes.

Wang Laboratories, Inc., is the only vendor to offer the flexibility of fixed/removable disk drives with a capacity in excess of 20 megabytes.

# DISK RESET/SYSTEM LOCKUP PROBLEM

Several 2200MVP installations have been experiencing system lockups when RESET is pressed while another partition is accessing a disk. In order to restore operation, the system must be powered off and on and reconfigured.

The problem occurs because the Master Device Table (MDT) was improperly setup by the user during system configuration. The MDT is setup by using the Edit Device Table function in the "@GENPART" utility. As described in the "2200MVP Introductory Manual" and Ch. 16 of the "2200VP/MVP Reference Manual," for disk controllers that respond to more than one address, only the primary address is specified. To be more specific, only one address is specified for each disk controller plugged into the CPU. For example, if a controller for a 2260C-2 was to address 10, 310 would be entered into the MDT; even though the disk responds to other addresses such as B10, 350, B50, 390 and 3DO, these addresses MUST NOT be entered into the MDT.

An existing configuration can be checked for multiple disk address entries by executing a LIST DT statement. The MDT entries are listed after the partition's device table. If the same address appears more than once in the display, the MDT has been improperly setup.

In order to prevent this problem from occuring in the

future, the next release of the MVP OS (Rel. 1.5) will automatically eliminate redundant disk addresses.
